Jonathan stated that Legislative Audit wants a group of Clerks and Treasurers to be included in the decision making process in devising this format. A motion was made and passed unanimously to allow President Jim Arnold to appoint Treasurers to this group. (Report is mandated by Ark Code Ann 14-21-102.attachment C)
- 4) Jim announced that the ATRAC group will meet July 8<sup>th</sup> at 10:30 at the AAC building and the next ACTA meeting will be November 17 & 18 in Eureka Springs at the Best Western. The 2006 meeting schedule is as follows: Feb 2 in Little Rock, June 6 in Hot Springs, October 10 in Fort Smith.
- 5) Jonathan announced that a meeting covering the new legislative issues pertaining to counties will be at the AAC building from 10 a.m. til 2 p.m. Monday and Wednesday of this next week.
- 6) Certificates and updates were distributed

# 14-21-102. Annual financial report.

(a)(1) The clerk of the county court shall make out or cause to be made out a full and complete annual financial report of the county, using the financial records of the county clerk and county treasurer, giving:
(A) A beginning cash balance;

(B) The amount of revenue from each source classification;

(C) The amount expended during the fiscal year for all purposes; and

(D) An ending cash balance.

(2) The annual county financial report shall include all operating accounts of the county for which the quorum court has appropriating control.

(3) The annual county financial report shall include a statement of the bonded indebtedness of the county.

(b)(1) The clerk of the county court shall cause to be published one (1) time in one (1) newspaper published in the county the annual financial report of the county. The report shall be published between January 15 and February 15 of each year for the previous fiscal year of the county.

(2) If no newspaper is published in such county, then the financial report is to be published in a newspaper having the largest circulation in the county.

#### May 24, 2005

Pursuant to Article III, Section 3 of the Constitution of the Arkansas County Treasurers' Association, the following amendment to the Bylaws is hereby promulgated by the executive committee:

Article IV, Section 1 of the Bylaws of the Arkansas County Treasures Association is hereby amended to read as follows:

Section 1. Executive Committee

The officers of the association shall be president, a vice-president, a secretary, a treasurer, an at-large member of the Association of Arkansas Counties Board, and two members of the AAC Legislative Committee. The immediate past president of the association shall be an officer and ex-officio member of the executive committee. The officers shall be elected by vote of a majority of the active members present and voting at the annual meeting of the association, to take office effective January 1 of the following year. Each term of office shall be two years. The officers of the association shall serve as the executive committee.

#### May 24, 2005

#### Pursuant to Article IV, Section 1 of the Constitution of the Arkansas County Treasurers' Association, the following amendment to the Constitution is herby proposed by the Executive Committee:

Article II, Section 1 of the Constitution of the Arkansas County Treasurers' Association is hereby amended to read as follows:

Section 1. Officers of the Association shall be: one President; one-Immediate Past-President; one Vice-President; one Secretary; one Treasurer; one at-large Member of the Board of the Association of Arkansas Counties and two Members of the Legislative Committee of the Association of Arkansas Counties. <u>The</u> <u>Immediate Past President of the Association shall be an officer and an ex-officio</u> <u>member of the Executive Committee.</u>

Purpose: Under current Article II, Section 1 language, the Immediate Past President of the Association is an officer. Under Article II, Section 2 "{[T]he officers listed in Section 1 of this article shall comprise the executive committee." Therefore, the Immediate Past President of the Association is an officer and voting member of the executive committee. The amended language is necessary to make the immediate past president an ex-officio (non-voting) member of the executive committee.

This amendment must be proposed by the executive committee at least 45 days before the meeting of the association that is held in conjunction with the Association of Arkansas Counties annual meeting. Article IV, Section 1. All members shall be notified by mail at least 30 days before aforesaid meeting. Article IV, Section 1.
